

**General Fees and Charges:**

**Building & Zoning Permits:** Fees for Building & Zoning Permits shall be based on the grand total estimated cost of the proposed work, including any subcontracts.

**The following fees shall apply** – A Flat Fee of \$5.00, plus \$1.00 per thousand dollars value, or portion thereof.

**Park & Recreation Charges:**

Use of the Community Center and the Ball field is on a first-come/first served basis; therefore, to ensure your desired date, please contact Town Hall to be put on the calendar. The Community Center is not reserved until the deposit has been paid.

**Community Center** – \$100.00 refundable security deposit

**Facility Rental, Town Resident** – \$50.00

**Facility Rental, Out-of-towner** – \$150.00

**Ball field, lighted** – \$35.00 per evening; automatic cut-off at 11:00pm

**Ball field, unlighted** – No charge; however, please call Town Hall to reserve field.

**Cemetery Fees:**

There are currently no vacant, unsold plots in the cemetery; however, the Town is expanding the cemetery by two acres, and will have new lots and plots available for sale soon.

A lot comprises four plots, each of which is 4 feet by 8 feet. Although it is anticipated that prices will change when the addition opens, rates are currently as follows:

\*\* These prices are estimates, and depend on the cost to the Town of the columbaria themselves

1. A 25% payment is due upon ordering the plot, or a signed waiver from the funeral home. A specific grave site within each lot shall be determined and specified by the immediate family and/or the funeral service. The Town shall NOT at any time specify individual grave locations.
2. **Definition of "in-town":** It was determined that all owners of residential property in the Town Limits, as well as all non-property owners who have been Town residents for at least 60 months prior to purchasing a plot, would be classified as "In-Town" for the purposes of purchasing plots at the In-town price; all others shall be charged the out-of-town rate.
3. **Bulk Lot Purchases on "spec.":** Funeral homes, etc. will not be allowed to make bulk purchases in anticipation of future business, and such businesses shall be limited to ten (10) lots per decade; however, single plots may be purchased on an individual basis for recently-deceased clients at the appropriate rates as defined in #2, above.

**Office Charges:**

**Freedom of Information Act searches** – Under FOIA, the following fees shall be charged: \$4.00 per quarter-hour, with a 15-minute minimum, plus 25¢ per page copied; charges shall be due at the time the requestor collects the documents.

**Copies** – 25¢ per page

**Faxes** – to send: \$1.00 per page; to receive: 25¢ per page

**Police Reports** – \$5.00 per report

**Returned check fee** – \$40.00
