

Minutes for Regular Board of Commissioners Meeting

Budget Amendment

Commissioner Thomas made a motion to approve the budget amendment adopting the insurance recovery funds. Commissioner Galloway seconded. Motion approved 5-0.

Committees and Potential Changes

Commissioner Thomas voiced his concern over the yearly 4th of July Fireworks event. Commissioner Thomas brought up for discussion the Town of Pikeville investing in the celebration or possibly taking over the event, including parades trunk or treat etc. Commissioner Thomas would like to see the Town Board work directly with Civic Organizations. Harry Lorello, the Town Attorney will research the structure of these events. Commissioner Katsenios is not against having the 4th of July celebration but would like to see funds spent on something more tangible that would benefit the citizens of the town.


Kellie West – Collingwood Drive, Pikeville
